## AND FINALLY, FROM THE PRESS



The Times reports this month that fracking has been suspended by the UK Government over the issue of earthquakes. It argues that more research is needed on the fracking-earthquake issue. Residents are now considering whether to sue the mining company Cuadrilla, over the Preston New Road earthquake last month. This was 2.9 on the Richter scale as against the 0.5 permitted by the Oil and Gas regulator.
